NOTIFICATION

MAHARASHTRA AGRICULTURAL PRODUCE MARKETING (DEVELOPMENT AND REGULATION) ACT, 1963.

No. Krubas.0113/C.R.46/11-C- Whereas, pursuant to the Model Act circulated by the Central Government, the Government of Maharashtra has, with a view to ensure benefit to the farmers, amended the Maharashtra Agricultural Produce Marketing (Development and Regulation), Act, 1963 (Mah. XX of 1964)(hereinafter referred to as the "said Act");

And Whereas, with a view to increase agricultural production and strengthen the agricultural marketing system, the State and Central Government have formulated various schemes;

And Whereas, by the Government Notification, Co-operation, Marketing and Textiles Department, No. Krubas 0113/C.R.46/11-C, dated the 18th December 2013, issued in exercise of the powers conferred by section 62 of the said Act, the Government of Maharashtra has invited the objections and suggestions to de-regulate certain processed agricultural products from the operation of the provisions of the said Act;

And Whereas, the objections and suggestions received pursuant to the said Notification have been considered;

And whereas, it is considered expedient to de-regulate the marketing of certain processed Agricultural Produce, specified in the Schedule appended to the said Act;

Now, therefore, in exercise of the powers conferred by section 62 of the Maharashtra Agricultural Produce Marketing (Development and Regulation) Act, 1963 (Mah. XX of 1964), the Government of Maharashtra, after consulting the Market Committees in the State, hereby amends the Schedule appended to the said Act, as follows, namely :—

In the Schedule appended to the said Act,—

- (i) In Entry III relating to Pulses, sub-entry 14 shall be deleted ;
- (ii) In Entry VI sub-entry relating to Gul and Sugar shall be deleted ;
- (iii) Entry XVII relating to Wheat Flour shall be deleted ;
- (iv) Entry XVIII relating to Dry Fruits shall be deleted ;
- (v) Entry XIX relating to Edible Oils shall be deleted.
