MAHARASHTRA CO-OPERATIVE SOCIETIES ACT, 1960.

No. CSL. 2016/C.R. 48/13-C.—In exercise of the powers conferred by section 3 of the Maharashtra Co-operative Societies Act, 1960 (Mah. XXIV of 1961), and in supersession of all other notifications or orders issued in this behalf, from time to time, in so far as they relate to conferment of powers of the Registrar to any other officer in respect of Co-operative Housing Societies of Slum Dwellers in the area of Thane Municipal Corporation the Government of Maharashtra hereby :—

(i) appoints the Assistant Registrar, Co-operative Societies, Slum Rehabilitation Authority, Thane as specified in column (2) of the Schedule appended hereto to assist the Registrar of Co-operative Societies, Maharashtra State, Pune within the area specified in column (3) of the Schedule ; and

(ii) Confers on him the powers of the Registrar specified in column (4) of the Schedule in respect of Co-operative Housing Societies of the Slum dwellers.
